The appellant vide his application dated 03.01.2022 informed the Commission that no information has been furnished to him by the SPIO of J.B. Law College, Chandmari, Guwahati till date. It is also informed that his authorized representative Sri B.K. Rai, Ex Asstt. Professor of IIT, Guwahati will represent him on date the of hearing i.e. on 12.01.2022. Through his letter dated 08.01.2022, it is informed that Sri B.K.
