ORDER

06.01.2022

The appellant is absent without step although he was directed to present his case personally in today's hearing as few points of his application are not clear and not understood.

Md. Toyab Ali, SPIO and Gram Sevak, Morongi Dev. Block is present and submits one written statement vide letter no. MDB/RTI-28/2018-19/9521 dated 04.01.2022.

Seen the case record. The appellant submitted one application dated 23.11.2020 under the RTI Act, 2005 before the SPIO, Morongi Dev. Block seeking certain informations. He did not receive the desired informations within the stipulated period of thirty days for which he submitted 1st appeal petition dated 22.01.2021 before the CEO and 1st appellate authority, Golaghat Zilla Parishad.

Seen the complaint dated 31.03.2021. It is contended that he was not furnished with the appropriate informations as sought for and not to his satisfaction.

Seen the RTI petition dated 23.11.2020. The sought for informations are as follows-

- (i) Total permanent staff of Morongi Dev. Block, their attendance register's Xerox certified copy, payment statements, service period etc.
- (ii) Performance reports from 2018 till date.
- (iii) Name and address of P.M. Kishan consumer of each G.P.
- (iv) Total numbers of P.M. Awaash.

Among the sought for informations **the SPIO is directed to furnish the names of permanent staff of Morongi Dev. Block. The appellant desires to have attendance register's, Xerox certified copy but he has not mentioned for which period, as such it was not provided with. The other three points 2, 3, and 4 could not be understood and the appellant is not present today to clear his contention. Therefore, he is directed to submit afresh application under the RTI Act, 2005 clearly indicating the informations he desires to have.**

With the above directions, the complaint dated 31.03.2021 is disposed of.
