O R D E R

05.01.2022

The complainant is absent without step.

The SPIO & Secretary, Boali Chengjur GP under Binnakandi Dev. Block is also absent without any intimation although notice of hearing has been served properly upon both the complainant as well the SPIO.

It is seen that the SPIO and Secretary, Boali Chengjur GP vide its letter dated 20.09.2021 has furnished the sought for informations to the appellant Sri Azmal Hussain.

Seen the case record. The appellant submitted one petition dated 27.07.2021 under the RTI Act, 2005 before the BDO, Binnakandi Dev. Block seeking certain informations. The BDO, Binnakandi Dev. Block transferred the said petition to the Secretary, Boali Chengjur GP vide letter no. BDB.282/RTI/2020-21 dated 06.08.2021 with a direction to furnish the informations directly to the petitioner within the stipulated period of time. The SPIO through his letter dated 20.09.2021 informed the petitioner that the sought for informations are available in different websites of Panchayat & Rural Dev. Department. He also indicated pointwise informations which are available in each portal had also been informed to the petitioner. However, in the petition, the complainant admits that he is in receipt of the letter of the SPIO & Secretary, Boali Chengjur GP dated 20.09.2021 and complained that he has not been furnished with the sought for informations. But from the letter of GP Secretary dated 20.09.2021, the name of different websites had been informed to the petitioner indicating availability of records against the sought for informations. It is observed that the complainant misread the informations furnished to him by the GP Secretary or he may not be able to find out the sought for informations in different websites of P & RD Deptt. If the fact is so, he may approach the GP Secretary to show him the sought for informations in different websites and the same may be downloaded and print out of the same may be taken.

In the context stated above, the complaint dated 01.10.2021 is disposed of. However, it is observed that the GP Secretary and SPIO fails to comply with the direction of the Commission communicated through its notice no. SIC/CCR.67/2021/12

dated 14.12.2021. He is cautioned to take necessary action immediately against any notice served upon him in future, and non-compliance of this direction will attract section 20(1) of the RTI Act, 2005 for imposition of penalty.
