The appellant is absent without step.

Sri Apurba Baruah, Executive Engineer i/c, and SPIO, DRDA, Kamrup is present. Sri Munin Talukdar, Junior Asstt. is also present.

The SPIO vide his letter no. RTI-2/2018/355 dated 04.01.2022 informed the Commission that neither the RTI petition dated 30.03.2021 nor the 1st appeal petition dated 11.05.2021 has been received by his office for which no action could be taken. However, he received the petition as well as the 1st appeal petition along with the notice of the Commission on 18.12.2021. On receipt of the same he immediately transferred the same to all the BDOs of Kamrup district vide letter no. RTI-2/2018/344 dated 23.12.2021 with a request to furnish the desired informations to the appellant. The appellant was also informed to collect the informations accordingly.

From the petition dated 30.03.2021, it observed that the desired informations are large in number and it relates to all the GPs of Kamrup district. Since the application has been transferred to all the BDOs of Kamrup district, the appellant is directed to collect the sought for informations from the BDOs office of Kamrup district. The BDOs of Kamrup district are directed to furnish the desired informations within next ten days of receipt of this order.

The SPIO, DRDA, Kamrup(R) is also directed to monitor and ensure that the informations are furnished to the appellant within ten days of receipt of this order.

With the above directions, the 2nd appeal is hereby disposed of.
