O R D E R
18/01/2022

1. The petitioner Sri Harinarayan Pathak has filed his RTI petition before the SPIO, Chief Minister's Office, Govt. of Assam, CM Block, 1st Floor, Janata Bhawan, Dispur, Guwahati on 26.11.2020 seeking some information relating to file notings. The SPIO of CM's Secretariat, Dispur then forwarded the RTI petition to SPIO, Industries & Commerce Department, Dispur on 21.12.2020.
2. On 4.10.2021, the petitioner filed 1st appeal before the 1st Appellate Authority, Office of CM's Secretariat, Dispur.

It is unfortunate that the petitioner who is debarred from filing RTI petition vide Case No. SIC/KP(M)302/2020 dated 15.2.2021 for one year on the ground of filing repetitive RTI petitions on different department by misusing the RTI Act,2005, has blatantly violated the provision of Section 19(1) of the RTI Act,2005 and filed 1st appeal petition almost after 10 months.

3. On not getting any reply, the petitioner filed 2nd appeal before the Commission on 8.11.2021. Accordingly, the matter was taken up for virtual hearing.
4. Since the petitioner has neither given his contact number nor his email id, he was intimated about video conferencing vide letter no. KPM 367/2020/7 dated 12.1.2022. But the petitioner did not come online through video conferencing.
5. The SPIO of Assam Industrial Infrastructure Development Corporation submitted a written statement dated 17.1.2022 stating that the information has already been provided to the petitioner on 12.1.2022.
6. Due to Covid related issue, the SPIO & GM of AIIDC is not available on video conferencing.
7. Since the information has already been provided, the instant 2nd appeal petition dated 8.11.2021 is disposed off.
