## O R D E R 16.09.2021

The appellant Shri Harinarayan Pathak is present.

Shri Ritumoni Pachani, SPIO and General Manager (Civil), Assam Industrial Infrastructure Dev. Corporation is present.

Perused the case record. The appellant submitted one petition dated 25.01.2021 under the RTI Act, 2005 before the SPIO of AIIDC seeking certain informations. The SPIO of AIIDC replied against the said petition vide letter no. AIIDC/3107/2021/2135 dated 03.03.2021. Being not satisfied with the informations so provided with the appellant submitted 1<sup>st</sup> appeal petition dated 15.03.2021 before the Managing Director and 1<sup>st</sup> appellate authority of AIIDC but no action was initiated by the FAA for which the petitioner submitted 2<sup>nd</sup> appeal dated 21.06.2021 before the Commission. The SPIO of AIIDC submitted written statement vide his letter no. AIIDC/3107/2021/2135 dated 09.09.2021. It is submitted that the informations sought by the appellant was on the matter of allotment letter of the land in favour of Gems and Jewellery Promotion Council of Assam, Industrial Estate, Bamunimaidam to establish a common facility centre for gold and Assamese traditional jewellery by Industries & Commerce Deptt., Government of Assam an agreement thereof. The appellant was given reply vide letter no. AIIDC/3107/2021/1582 dated 03.03.2021 mentioning that no land allotment was made by AIIDC to Gems and Jewellery Promotion Council of Assam, Industrial Estate, Bamunimaidam to establish a common facility centre for gold and Assamese traditional jewellery by Industries & Commerce Deptt., Government of Assam, and as such, no agreement was signed for which the sought for informations could not be furnished.

It is gathered from the written statement of the SPIO, AIIDC that the sought for informations is not part of record, and it is also not available at all for which the same could not be furnished to the appellant and it was informed accordingly.

In view of the above, the 2<sup>nd</sup> appeal dated 21.06.2021 is disposed of.
