The appellant is absent. However, he has submitted one written statement vide letter no. Nil dated 05.11.2021 through e-mail which has been received by the Commission on 08.11.2021.

The Circle Officer, Athani Rev. Circle has submitted written statement vide letter no. ATC.8/2016/244 dated 29.10.2021. The Circle Officer, Athani Rev. Circle submits that the sought for informations had already been furnished by the Executive Officer, Sapatgram Municipal Board vide letter no. SMB/RTI/Vol.2/2020-21/836 dated 09.03.2021 and letter no. SMB/RTI/Vol./2021-22/2 dated 22.04.2021.

The appellant has enclosed letter of i/c Asstt. Settlement Officer, Athani Rev. Circle bearing no. ATC.8/2016/214 dated 13.12.2020 whereby the appellant was furnished informations. The appellant through his written statement dated 05.11.2021 contended that the SPIO of Athani Rev. Circle has suppressed the informations, and no specific informations has been furnished to him. While going through the application dated 15.10.2020 under the RTI Act, 2005 addressed to the Sub-Divisional Officer, Bilasipara it can't be understood what information the appellant requires to have. **Therefore, the Commission directs the appellant to submit affidavit clearly indicating his sought for informations in his petition dated 15.10.2020, the informations he has received from the Circle Officer, Athani Rev. Circle and Executive Officer, Sapatgram Municipal Board. He will also clearly indicate his contention stating how the informations furnished to him is not to-the-point of his RTI application. He is also directed to endorse copies of the affidavit to the SPIO of Athani Rev. Circle and Executive Officer, Sapatgram Municipal Board so as to enable them to defend their stand on the allegations. The Registry will send a photocopy of the written statement of Sri Nripendra Das the appellant dated 05.11.2021 to the SPIO of Athani Rev. Circle and Sapatgram Municipal Board. They will submit report against the allegations therein within fifteen days.**

The appellant and SPIOs of Athani Rev. Circle as well as Sapatgram Municipal Board will present their cases personally on next date of hearing.

Fix next date of hearing on 22.12.2021 at 12:00 Noon. This order shall constitute notice for hearing.
