The PIO, o/o the Bilasipara Civil Sub-Division Territorial Road Division vide his letter no. BLP/tech/RTI/2019-20/59/2009 dated 02.11.2021 informs the Commission that the sought for informations of the application dated 06.11.2020 under the RTI Act, 2005 were furnished to the appellant on 25.11.2020 vide letter no. 2067 by the Asstt. Executive Engineer, PWD, Bilasipara East Territorial Road Sub-Division and by the same letter the appellant was requested to collect the copy of the estimate of the scheme VIZ “Construction of RCC Bridge No.1/1 on Bilasipara Batapara Road under RIDFXXIV FOR 2018-19.”

Seen the 2nd appeal petition dated 24.02.2021. The appellant submitted that he has not been furnished with any informations against his application dated 06.11.2020. Further, he alleged that the SPIO has refused to receive the same.

On perusal of the case record, it is seen that the allegations against the SPIO seems to be not true as his application dated 06.11.2020 was replied to on 25.11.2020. It is also informed by the SPIO that copy of the plan & estimate of the above stated scheme has been collected by the appellant on 31.10.2021.

Since the sought for informations along with the copy of the plan & estimate of the scheme has already been received by the appellant, as such, the 2nd appeal dated 24.02.2021 is disposed of.
