The appellant is absent.

The 1<sup>st</sup> appellate authority i.e. the Addl. Deputy Commissioner, Hojai is neither represented nor submitted any written statement in respect of action taken to dispose of the 1<sup>st</sup> appeal petition dated 02.06.2020.

The PIO of Hojai Municipal Board is absent. However, he submitted written statement vide letter no. HMB/RTI/2017-18/1274-76 dated 27.10.2021. Through the written statement, the PIO of Hojai Municipal Board submitted that the sought for informations had been furnished to the appellant vide letter no.
