**O R D E R**

08.11.2021

The appellant has informed through e-mail dated 08.11.2021 that although he has received the sought for informations from the SPIO, o/o the Executive Engineer, PWRD Dokmoka Road Division but he alleged that the informations so received are misleading and unsatisfactory. Therefore, he requests the Commission to pass order to the SPIO to provide him with appropriate informations.

Sri Nayanjyoti Konwar, Junior Engineer, as authorized by the EE, PWRD Dokmoka Road Division is present. The EE, PWRD Dokmoka Road Division vide his letter no. CIR-XI/2015/Pt12129 dated 08.11.2021 informs the Commission that all the sought for informations had been furnished to the appellant vide letter no. CIR-XI/2015/Pt.-1/118 dated 27.10.2021. He also submits a photocopy of the office copy of the letter signed by the appellant Sri Subrata Nath.

The appellant alleges that the SPIO has furnished him misleading and unsatisfactory informations but he is not present today to raise his contention on which point he is not satisfied and which information is misleading. **Therefore, the Commission directs the appellant to submit his allegations pinpointing which informations is unsatisfactory and misleading to the SPIO, o/o the EE, PWRD, Dokmoka Road Division.**

**The SPIO, o/o the EE, PWRD Dokmoka is directed to furnish the appropriate informations on receipt of the written allegations from the appellant Sri Subrata Nath. On receipt from the appellant, he will review the already furnished informations and will submit to-the-point informations if there be any.**

**With the above directions, the 2<sup>nd</sup> appeal dated 04.03.2021 is disposed of.**
