**O R D E R**

The appellant Sri Ayush Bagaria is present.

Sri Rajib Neog, Associate Planner & deemed PIO of Guwahati Municipal Corporation is present.

Perused the case record. The appellant submitted one petition dated 31.08.2020 under the RTI Act, 2005 before the SPIO, o/o the GMC seeking certain informations. He did not receive the desired informations within the stipulated period of 30 days and so preferred 1<sup>st</sup> appeal dated 12.10.2020 before the 1<sup>st</sup> appellate authority of GMC. The FAA through his order dated 18.01.2021 directed the PIO of GMC to furnish the sought for informations within 15 days to the appellant if the same is available. Still, the appellant did not receive the desired informations and as such preferred 2<sup>nd</sup> appeal before the Commission on 10.03.2021.

The appellant informs that he has not received the desired informations till date.

The deemed PIO of GMC submits orally that the sought for informations could not be furnished to the appellant as per judgment and order of the Hon'ble Delhi High Court in a certain case had debarred issue of this kind of informations i.e. full drawing and approved plan of a building. **The Commission directs the PIO of GMC to give a reply to the appellant stating the reasons for not furnishing the sought for informations citing order of the Hon'ble Delhi High Court.**

**The 2<sup>nd</sup> appeal dated 10.03.2021 is disposed of.**
