The appellant Sri Ayush Bagaria is present.

Sri Rajib Neog, Associate Planner & deemed PIO of Guwahati Municipal Corporation is present.

Perused the case record. The appellant submitted one petition dated 03.09.2020 under the RTI Act, 2005 before the SPIO, o/o the GMC seeking certain informations. He did not receive the desired informations within the stipulated period of 30 days and so submitted 1<sup>st</sup> appeal petition dated 12.10.2020 before the 1<sup>st</sup> appellate authority of GMC. The FAA through his order dated 18.01.2021 directed the PIO of GMC to furnish the sought for informations within 15 days, but the appellant was not furnished with the sought for informations within 15 days of order dated 18.01.2021 for which he preferred 2<sup>nd</sup> appeal before the Commission on 03.04.2021.

The appellant submits orally that he has been given information by the SPIO of GMC vide letter no. GMC/RTI/FAA/23/2020/14882 dated 06.05.2021 that no action taken report is found in file against the letter. It is observed that the informations furnished by the PIO of GMC is not rational. The appellant sought for two informations whereas informations against ten queries has been furnished. Therefore, the Commission directs the PIO of GMC to review the informations already furnished to the appellant, make necessary correction if required, and furnish appropriate informations to the appellant within 30 days of receipt of this order.

With the above direction, the  $2^{nd}$  appeal dated 03.04.2021 is disposed of.
