**O R D E R**

02.11.2021

The appellant is absent.

The SPIO, o/o the Mahammedpur Jaykrishnapur GP is absent without any intimation.

The 1<sup>st</sup> appellate authority has not submitted any written statement in respect of action taken against 1<sup>st</sup> appeal petition dated 27.01.2021.

The case is taken up for hearing in absence of the SPIO as the 2<sup>nd</sup> appeal is pending since 27.07.2021.

Perused the case record. The appellant vide his petition dated 25.11.2020 under the RTI Act, 2005 sought certain informations from the SPIO and Secretary of Mahammedpur Jaykrishnapur GP. As no informations was received by him, he submitted 1<sup>st</sup> appeal petition dated 27.01.2021 before the Chief Executive Officer, Zilla Parishad, Hailakandi. The 1<sup>st</sup> appellate authority forwarded the 1<sup>st</sup> appeal petition to the Secretary of Mahammedpur Jaykrishnapur GP vide letter no. HZP.738/RTI/Pt/2014-15 dated 01.02.2021 with a direction to furnish the required informations to the appellant within seven days. From the documents available with the case record, no action is seen to have taken by the SPIO of Mahammedpur Jaykrishnapur GP. Therefore, the appellant submitted 2<sup>nd</sup> appeal which was received by the Commission on 27.07.2021.

**Seen the application dated 01.12.2020. The informations sought by the appellant should be maintained by the Secretary of Mahammedpur Jaykrishnapur GP. Therefore, the Commission directs the Secretary & SPIO of Mahammedpur Jaykrishnapur GP to furnish the sought for informations to the appellant within two weeks' time from the date of receipt of this order.**

**With the above directions, the 2<sup>nd</sup> appeal is disposed of.**
