## <u>O R D E R</u>

The appellant/complainant Sri Jibeswar Kalita through his e-mail dated 29.10.2021 informs the Commission that he is unable to attend today's hearing for ailment of his mother. He also requests the Commission to direct the SPIO of o/o the Superintendent of Police, Golaghat to furnish the informations in respect of point numbers 3 and 4 of his RTI petition dated 23.11.2020.

The SP, Golaghat vide his letter no. GLT/CB/RTI/2021/424 dated 29.10.2021 submitted before the Commission that the sought for informations against petition dated 23.11.2020 had been furnished vide letter no. GLT/CB/RTI-21/2021/46 dated 25.01.2021. Also the 1<sup>st</sup> appeal petition dated 20.01.2021 was attended to and replies had been given vide letter no. GLT/CB/RTI/2021/55 dated 31.01.2021.

Since action has been taken against RTI petition as well as the 1<sup>st</sup> appeal petition, the Superintendent of Police, Golaghat requests to dispense with personal appearance of the PIO of his office. Prayer granted.

Perused the case record. The appellant submitted one petition dated 23.11.2020 under the RTI Act, 2005 before the SPIO, o/o the Superintendent of Police, Golaghat seeking certain informations. The sought for informations were furnished to him by the SPIO, o/o the SP, Golaghat vide letter no. GLT/CB/RTI/2021/46 dated 25.01.2021. The appellant claims that he did not receive the sought for informations in time and thus, submitted 1<sup>st</sup> appeal petition dated 20.01.2021 before the 1<sup>st</sup> appellate authority, o/o the SP, Golaghat. The FAA further furnished the informations vide letter no. GLT/CB/RTI/2021/55 dated 31.01.2021 against 1st appeal dated 20.01.2021. Still the appellant was not satisfied with the informations so furnished to him and preferred 2<sup>nd</sup> appeal dated 10.04.2021 before the Commission which was received by the Commission on 19.04.2021.

Seen the petition dated 23.11.2020 and informations furnished to him by the SPIO of SP's office, Golaghat. The contention of the appellant is that informations in respect of point numbers 3 and 4 of his petition has not been furnished properly. By point number 3 he desires to get the Utilization Certificate (UC) of amount paid to each VDP under Dergaon Police

Station. He was answered that the amount paid to VDP is pocket money only and the office did not maintain Utilization Certificate for the same. The appellant further requested for performance report of all VDP and names of President and Secretary of each VDP including their full address, their bank account nos. and all transactions therein. The informations so sought under point number 4 are personal information of third party and there is cause of interest is cited in the application for which the sought for informations may not be furnished.

Therefore, the Commission observes that the informations furnished to the appellant against his petition dated 23.11.2020 does not need rejoinder from the SPIO.

With the above observations, the complaint petition dated 10.04.2021 is disposed of.
