The appellant Smti. Kakoli Debnath is present.

Smti. Dipika Roy Medhi, Vice-Principal & SPIO of Pragjyotish College is present and submits one letter bearing no. PC/RTI/2020/228 dated 30.10.2021.

One e-mail dated 20.10.2021 submitted by Smti. Kakoli Debnath has been received by the Commission whereby it is informed that no informations has been received by the appellant till date. Further, she expresses dissatisfaction that the 1st appellate authority of Pragjyotish College did not arrange hearing to dispose the 1st appeal dated 01.03.2021 in accordance with the provisions of the RTI Act, 2005. However, she is in receipt of one letter from the Principal of Pragjyotish College bearing no. PC/RTI/2020/64 dated 15.07.2021.

Perused the case record. The appellant submitted one petition dated 11.01.2021 under the RTI Act, 2005 before the SPIO of Pragjyotish College, Guwahati seeking certain informations. She did not receive the sought for informations within the stipulated period of time and therefore submitted one 1st appeal petition dated 01.03.2021 before the FAA. Still she neither received the informations nor the FAA of Pragjyotish College arranged hearing on the 1st appeal petition. Being aggrieved, she preferred 2nd appeal before the Commission on 29.04.2021.

The Vice-Principal & SPIO of Pragjyotish College has submitted one letter submitting the Commission copies of the replies of sought for informations. The SPIO is directed to furnish the sought for informations as admissible under the RTI Act, 2005 to the appellant within seven days of receipt of this order and will submit a compliance report before the Commission. The SPIO is also directed to take timely action on any application under the RTI Act, 2005 in future.

With the above directions, the 2nd appeal is hereby disposed of.
