<u>ORDER</u> 18-11-2021

- 1. The appellant Dr. Santanu Acharjee is present.
- 2. The SPIO/Principal, Debraj Roy College, Golaghat, Assam, is absent. But the Commission has received a written statement No. DRC/917/2021 dated 16.11.2021 from the SPIO/Principal, Debraj Roy College, Golaghat, Assam, informing that the information sought by the appellant has been already provided. Shri Joyram Hazarika, SPIO and Deputy Director, Directorate of Higher Education, Government of Assam, is also present on behalf of the First Appellate Authority.

The SPIO/Principal, Debraj Roy College, Golaghat, shall also submit an Action Taken Report on this order immediately on expiry of the 15 (fifteen) day period.
- 5. With the above order, this 2nd Appeal is hereby disposed of.
