- 1. The appellant Shri Abudul Barek is absent without any intimation.
- 2. The SPIO, O/o the Block Development Officer, Gomafulbari Development Block, Barpeta, Assam, is absent. The Block Development Officer, Gomafulbari Development Block, Barpeta, has however sent a person by the name Shri Amarjit Ojah, (Jr. Asstt), Gomafulbari Anchalik Panchayat, to the hearing today. Shri Amarjit Ojah submitted a letter No. GBD-5/RTI/2012-13/1119 dated 16.11.2021 written by the Block Development Officer, Gomafulbari Development Block, Barpeta, to Shri Amarjit Ojha directing him to attend the hearing and marked a copy to the Commission. They are also directed to submit a written statement each on the disposal of the RTI application submitted by the appellant Shri Abdul Barek on or before the next date of hearing.
- 5. This order shall constitute the notice of hearing.
