O R D E R

- 1. The appellant Shri Narayan Bora is absent. But he has sent a letter to the Commission on 08.11.2021 praying for absence for today's hearing, in view of some family problem.
- 2. The SPIO, Assam State Freedom Fighters' Association, Rupnagar, Bhangagarh, Guwahati, Assam is absent. But he has authorized advocates Smti Junmoni Devi Khaund, Smti Barnali Paul, Smti Sanu Baruah to appear on his behalf. Accordingly Smti Junmoni Devi Khaund, and Smti Sanu Baruah both advocates have submitted a vakalatnama and have appeared in the hearing which was held despite the absence of the appellant in the interest of speedy disposal and in the interest of speedy access to information. The SPIO shall also submit an Action Taken Report on expiry of 21 (twenty-one) days. The appellant's prayer for fixing a fresh hearing date is not entertained.
- 4. With the above order, this 2nd Appeal is hereby disposed of.
