ORDER 11-11-2021

- 1. The appellant Shri Gole Rahman Ahmed is present.
- 2. The SPIO/Head Master, Kodomtoli L.P. School, P.O. Hazirhat, P.S. Sukchar, Distt South Salmara Mankachar, Assam is absent. But the Commission has received a letter on 11.11.2021 from Mrs Sakeba Khatun, Head Mistress cum Member Secretary of Kodomtoli L.P. School, stating that she is no longer Head Mistress cum Member Secretary of the said school and that the Deputy Inspector of Schools, South Salmari Mankachar has appointed Shri Ram Charan Bordoloi, Asstt. Teacher as i/c Head Master cum Member Secretary of the said School vice Smti Sakeba Khatun to resign as Head Mistress cum Member Secretary on 28.09.2021. Smti Sakeba Khatun has also enclosed photocopy of an order (Memo No. SSM/SB/2020/707-11 dated 05.10.2020) issued by Deputy Inspector of Schools, South Salmara Mankachar, Hatsingimari, appointing Shri Ram Charan Bordoloi as i/c Head Teacher cum Member Secretary vide Smti Sakeba Khatun.
- Smti Sakeba Khatun has also submitted photocopy of an FIR submitted by her to the Sukchar P.S. on 15.06.2021 stating that some miscreants had broken into the Kadamtoli L.P. School on the night of 14.06.2021 and taken away certain items, a list of which is also mention in the said FIR.
- 4. From perusal of records it is seen that while the appellant Shri Gole Rahman Ahmed had submitted his RTI application on 08.07.2020, the theft took place in the school on 14.06.2021, which is clearly 11 months after submission of the RTI petition.
- Documents submitted by Smti Sakeba Khatun also contains photocopy of an attendance sheet of hearing and 1<sup>st</sup> Appeal on the matter conducted by BEEO, South Salmara Mankachar on 23.09.2020.
- 6. The Commission is not in a position to dispose this matter today because of the absence of the SPIO/Head Master, Kodomtoli L.P. School, in the hearing. But going by the claims of Smti Sakeba Khatun that a theft had occurred in the School 11 months after the RTI application was filed by Shri Gole Rahman Ahmed, the BEEO, P.O. & P.S., South Salmara Mankachar, Distt. South Salmara Mankachar, is directed to (i) conduct an enquiry into the entire matter, and also (ii) take necessary steps so that Shri Gole Rahman Ahmed is furnished with all the informations he has sought vide his RTI application dated 08.07.2020 within 21 (twenty-one) days from the receipt of this order.
- 7. The Deputy Inspector of Schools, South Salmara Mankachar, Hatsingimari, is directed to take necessary steps and ensure that Shri Gole Rahman Ahmed is furnished with

the informations by the BEEO and or i/c Head Master cum Member Secretary, Kodomtoli L.P. School as directed.

8. The BEEO, South Salmara Mankachar, Hatsingimari, is directed to submit an Action Taken Report on this order immediately upon expiry of the said 21 (twenty-one) days.
