## <u>ORDER</u> 12/01/2022

- The petitioner has filed his RTI petition before the PIO, O/o the Superintendent of Police, Goalpara on 28.4.2021 seeking some report from Goalpara P.S. Case No. 415/2019 u/s 279/338 IPC. Reportedly on not getting any information, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority of the O/o the Superintendent of Police, Goalpara on 24.6.2021. Then he filed 2<sup>nd</sup> appeal petition before the Commission on 28.9.2021.
- 2. Accordingly, the virtual hearing was taken today and intimation was issued to both petitioner and the SPIO.
- 3. The SPIO is represented by his advocate Mrs Sumita Kakati who has said that information has already been sent through ordinary post.
- 4. Since the petitioner has said that he has not received any information, the advocate is advised to brief his client to send all future RTI replies through registered post and intimate about it to the Commission as and when required. In that case, all question of non receipt of the petition will not be entertained at the Commission.
- 5. The petitioner said that he has not received the information. Since the copy of the information is sent to the Secretary of the Commission by the PIO, and there is also every possibility of the petitioner not receiving the same, if sent through post, the petitioner is advised to collect the same from the Secretary of the Commission.
- 6. The case is disposed off.
