O R D E R

The appellant is absent without step in consecutive two days of hearing. He might have lost interest on his appeals/informations.

Sri Ranjan Bhuyan, Superintendent of Police, Dhemaji and 1st appellate authority is present and submits written statement on the status of Hon'ble State Police Accountability Commission (SPAC), Assam's case no. 89/2017 vide his letter no. DMJ/CRM/RTI/2022/1684 dated 12.02.2022. It is submitted that SPAC case no. 89/2017 has already been disposed of on 22.10.2019.

Perused the case record. The appellant submitted one petition dated 22.06.2017 under the RTI Act, 2005 before the SP, Dhemaji seeking certain informations. The Deputy Superintendent of Police HQ and PIO, o/o the SP, Dhemaji furnished informations against point number 1 of the RTI application dated 22.06.2017 to the applicant and in respect of point number 2, information was not furnished since the SPAC case no. 89/2017 was under investigation and as such, informations could not be furnished at that time. Being aggrieved, the appellant submitted 1st appeal petition dated 04.08.2017. But the desired informations were not furnished to the appellant for which the appellant preferred 2nd appeal dated 03.01.2018 before the Commission.

Seen the letter of SP, Dhemaji bearing no. DMJ/CRM/RTI/2022/1684 dated 12.02.2022. It is submitted that the SPAC case No. 89/2017 has already been disposed of on 22.10.2019 as per information received from the Secretary, SPAC vide letter no. SPAC/C/109/SP(DMJ)/17/128 dated 10.02.2022.

The contention of the appellant was that he was not provided with the informations related to point number 2 of the RTI application dated 22.06.2017 and the then SPIO informed that the same could not be furnished as it was under investigation by the Hon'ble State Police Accountability Commission (SPAC), Assam. Since the case no. 89/2017 has now been disposed of, therefore the sought for informations can now be furnished by the SPIO of SP's office, Dhemaji. **The Commission therefore, directs the SPIO, o/o the SP, Dhemaji to furnish the desired informations against point number 2 of the application dated 22.06.2017 to the appellant within three days of receipt of this order.**

With the above directions, the 2nd appeal dated 03.01.2018 is disposed of.
