**O R D E R**

14.02.2022

The appellant Sri Shahjahan Miah is present.

The SPIO of Jamadarhat Dev. Block is absent without step although he/she has been directed by the CEO, Dhubri Zilla Parishad to attend today's hearing vide letter no. ZPD-52/Pt-XII/RTI/2020-21/237 dated 10.02.2022.

Sri Kalyan Kumar Talukdar, Asstt. Engineer and ASPIO, Jamadarhat Dev. Block is present without authorization.

Perused the case record. The appellant submitted one petition dated 15.06.2021 under the RTI Act, 2005 before the SPIO of Jamdarhat Dev. Block seeking certain informations. He was not provided with the informations for which he submitted 1<sup>st</sup> appeal petition dated 23.09.2021 before the CEO, Dhubri Zilla parishad. The CEO, Dhubri Zilla parishad and 1<sup>st</sup> appellate authority organized hearing against 1<sup>st</sup> appeal petition dated 23.09.2021 fixing date of hearing on 27.09.2021 and disposed the same directing the SPIO of jamadarhat Dev. Block to furnish the sought for informations to the appellant within seven days vide his order no. ZPD-52/PT-XII/RTI/2020-21/69 dated 08.10.2021. The SPIO did not furnish the informations even after receipt of the direction from the CEO, Dhubri Zilla parishad and the appellant therefore, submitted 2<sup>nd</sup> appeal dated 26.10.2021 before the Commission.

Seen the application dated 15.06.2021. The sought for informations are very much part of record maintained by the o/o the Jamdarhat Dev. Block and by the concerning implementing Gaon Panchayat. **Therefore, the SPIO of Jamdarhat Dev. Block is directed to furnish the desired informations to the appellant within three days of receipt of this order and submit compliance report. The Principal Secretary, Panchayat & Rural Development Deptt., Government of Assam will draw up departmental proceedings against the SPIO of Jamdarhat Dev. Block who has not furnished the informations deliberately, and defied the order of the CEO, Dhubri Zilla Parishad and violate the provision of the RTI Act, 2005. He will impose penalty as per rule.**

**With the above directions, the 2<sup>nd</sup> appeal dated 26.10.2021 is disposed of.**
