**O R D E R**

The appellant Sri Pranjit Deka is present.

Sri Junmoni Saikia, Secretary, Bordoulguri GP and SPIO is also present.

Perused the case record. The appellant submitted one application dated 27.07.2021 under the RTI Act, 2005 before the SPIO of Sipajhar Dev. Block seeking certain informations. The SPIO of Sipajhar Dev. Block transferred the RTI application to the Secretary of Bordoulguri GP to furnish the desired informations directly to the appellant. For non-receipt of the sought for informations, the appellant submitted 1<sup>st</sup> appeal petition dated 02.09.2021 before the BDO, Sipajhar Dev. Block. It is seen that the Secretary and SPIO of Bordoulguri GP informed the appellant vide letter no. nil dated 06.08.2021 that the sought for informations are not available in the GP office but he did not transfer the application to the custodian of the informations. Hence, the appellant preferred 2<sup>nd</sup> appeal dated 06.10.2021 before the Commission.

Seen the application dated 27.07.2021. The informations of point numbers 2 and 3 of the RTI application should be maintained either by the GP office or by the BDO's office. **Therefore, the Commission directs the Secretary, Bordoulguri GP to furnish the sought for informations within seven days of receipt of this order. If any informations is not available that should be specifically informed to the appellant.**

**With the above directions, the 2<sup>nd</sup> appeal dated 06.10.2021 is disposed of.**
