The appellant/complainant Sri Dilip Nath is present.

Sri Krishna Kanta Pegu, Sub-Divisional Engineer, Majuli Electrical Sub-Division is present and submits one written statement vide letter no. SDE/MESD/APDCL/G-32/2022/756 dated 07.02.2022. It is submitted that the appellant submitted two applications on the same date i.e. on 14.06.2021 before the CEO, Jorhat Electrical Circle, APDCL and before the SDE, Majuli Electrical Sub-Division seeking certain informations. The CEO, Jorhat Electrical Circle, APDCL collected the sought for informations from all the Sub-Divisions under his jurisdiction and the SDE, Majuli also furnished the informations pertaining to his Sub-Division and misunderstood that the informations sought by the application submitted by the appellant on the same date should not be furnished. Because of this misunderstanding he did not furnish the sought for informations to the appellant. However, he has prepared and submitted the desired informations to the Commission along with the same letter. **The Commission therefore directs the Sub-Divisional Engineer, Majuli Electrical Sub-Division to furnish the sought for informations directly to the appellant within three days of receipt of this order.**
