O R D E R

07.02.2022

The appellant is absent without information.

The SPIO of Sagunmari GP under Nayeralga Dev. Block is also absent without step.

The 1st appellate authority, o/o the Nayeralga Dev. Block has not submitted written statement against Commission's notice no. SIC/DHR.67/2021/13 dated 20.01.2022.

The case is taken up for hearing in absence of both parties as the 2nd appeal is pending since 26.10.2021.

Perused the case record. The appellant submitted one petition dated 13.07.2021 under the RTI Act, 2005 before the Secretary & SPIO, Sagunmari Gaon Panchayat under Nayeralga Dev. Block seeking certain informations. He did not receive the desired informations within the stipulated period of time for which he submitted 1st appeal petition dated 23.08.2021 before the BDO and FAA of Nayeralga Dev. Block. Still, he did not receive the desired informations and thus preferred 2nd appeal dated 26.10.2021 before the Commission.

Seen the petition dated 13.07.2021. The appellant sought for informations against MGNREGA of 2020-21 and 15th Finance Commission scheme of Sagunmari GP. The number of informations sought for are 14 in total which seems to be large in number. **Therefore, the SPIO and Secretary, Sagunmari GP is directed to invite the appellant on a mutually convenient date for inspection of documents. He will provide 30 copies of informations/documents free of cost, and for the rest, the appellant will pay at the prescribed rate.**

With the above directions, the 2nd appeal dated 26.10.2021 is disposed of. However, the SPIO and Secretary, Sagunmari GP and the FAA of o/o the Nayeralga Dev. Block are cautioned not to make such delay in furnishing informations against any RTI petitions in future.
