**O R D E R**

01.02.2022

The appellant Sri Nurul Ahmed is present.

The SPIO, o/o the SDO(C), Dhansiri Sub-Division and Circle Officer, Sarupathar Rev. Circle are absent.

Perused the case record. The appellant Sri Nurul Ahmed submitted one petition dated 24.10.2019 under the RTI Act, 2005 before the SPIO, o/o the SDO(C), Dhansiri seeking certain informations. He did not receive the desired informations within the stipulated period of time for which he submitted 1<sup>st</sup> appeal petition dated 19.12.2019 before the Deputy Commissioner, Golaghat. He has submitted one 1<sup>st</sup> appeal dated 30.12.2019 before the SDO(C), Dhansiri also. The DC, Golaghat transferred the said petition to the SDO(C), Dhansiri Sub-Division and informed the petitioner accordingly. The RTI petition dated 24.10.2019 was transferred by the SPIO of o/o the SDO(C), Dhansiri to the Circle Officer, Sarupathar Rev. Circle with a direction to take necessary action. Accordingly, the Circle Officer, Sarupathar Rev. Circle vide his letter no. SPR.24/2007-08/RTI dated 05.02.2020 informed the appellant that the sought for informations in respect of point numbers 1, 2, 3 and 4 of the RTI application dated 24.10.2019 are not related to his office, and informations in respect of point numbers 5, 6 and 7 are available in the DC's office, Golaghat since the case record was submitted for correction of Sadar Jamabandi.

The appellant submits orally that he has received the informations in respect of point numbers 5, 6 and 7 from the o/o the DC, Golaghat. The SDO(C), Dhansiri submitted written statement in respect of Commission's notice no. SIC/GLT.19/2020/18 dated 27.10.2020. It is submitted that the applicant has been provided with a certificate no. DAFIC.23/2010/Pt-I/360 dated 27.01.2016 and Jamabandi no. SPR/JB/2428/2016 and Death Certificate no. 0158043 of Late Kutub Uddin Ahmed etc. On query, the appellant submits orally that he is not in receipt of such information from the SDO(C), Dhansiri. **Therefore, the SPIO, o/o the SDO(C), Dhansiri is directed to furnish the informations related to point numbers 1, 2 and 4 of the RTI application dated 24.10.2019 within seven days of receipt of this order, free of cost. The point number 3 may also be considered by him if pleased.**

**With the above directions, the 2<sup>nd</sup> appeal dated 13.05.2020 is disposed of.**
