**O R D E R**

01.02.2022

The appellant is absent.

The SPIO, o/o the Lawkhowa Dev. Block is absent without any information.

The 1<sup>st</sup> appellate authority, Addl. Deputy Commissioner i/c Kaliabor Sub-Division submitted written statement dated 18.04.2021. It is submitted that the petitioner submitted a petition dated 08.09.2020 under the RTI Act, 2005 before the SDO (C), Kaliabor Sub-Division seeking some informations. Since the informations related to Kathpara Gaon Panchayat under Lawkhowa Dev. Block, hence the SPIO, o/o the SDO(C), Kaliabor transferred the RTI application to the BDO, Lawkhowa Dev. Block vide letter no. KMM(RTI)03/2017(Pt-II)/6639 dated 14.09.2020. For not receiving the informations the appellant submitted 1<sup>st</sup> appeal dated 09.10.2020 before the SDO (C), Kaliabor Sub-Division which was also forwarded to the BDO, Lawkhowa Dev. Block for taking necessary action. Even after that the SPIO of Lawkhowa Dev. Block did not furnish the sought for informations to the appellant for which he submitted 2<sup>nd</sup> appeal dated 29.12.2020 before the Commission.

Seen the RTI application dated 08.09.2020. The sought for informations are very much part of record to be maintained either by the BDO's office, Lawkhowa Dev. Block or by the Secretary of Kathpara GP under Lawkhowa Dev. Block. **Therefore, the SPIO & Secretary, Kathpara GP is directed to furnish the desired informations to the appellant within seven days of receipt of this order, free of cost. He is further cautioned not to make delay in furnishing informations against RTI petitions in future.**

**With the above directions, the 2<sup>nd</sup> appeal dated 29.12.2020 is disposed of.**
