ORDER 21-10-2021

- 1. The appellant Shri Ansarulla Laskar is present.
- 2. The SPIO, O/o the CDPO, Lala ICDS Project, Distt. Hailakandi is absent. But the Commission has received a written statement No. CDPO/Lala/223/AWC/2009-10 dated 18.10.2021 informing that the portions of the informations related to the RTI query of the appellant Shri Ansarulla Laskar was allegedly forcibly snatched away by the appellant Shri Ansarulla Laskar from Smti. Halima Begum Laskar, Anganwadi worker, Centre No. 02, Vill. Mohammedpur-II on 15.03.2016. It has been also stated that while an FIR was lodged with the Lala P.S. (copy enclosed), the matter is sub judice in the court of Chief Judicial Magistrate, Hailakandi. A copy of the FIR has been enclosed with the written statement wherein it has been stated that several valuable office documents including bank passbook, attendence register, utilization register and SMP fund register etc. have been snatched away.
- 3. In view of the fact that the matter is sub judice in the Court of the Chief Judicial Magistrate, Hailakandi, vide case No. Gr.482/16 (copy enclosed with written statement), the Commission is of the considered view that the 2<sup>nd</sup> Appeal of Shri Ansarulla Laskar will be taken up only after the matter is disposed of by the said court. Accordingly, the SPIO, O/o the CDPO, Lala ICDS Project and the appellant Shri Ansarulla Laskar are directed to approach this Commission once the Court declares the sub judice matter as closed.
- 4. With the above order, this 2<sup>nd</sup> Appeal is hereby disposed of.
