<u>O R D E R</u> 07-10-2021

- 1. The appellant Shri Moynal Hoque is absent without any intimation.
- The SPIO, O/o the District Social Welfare Officer and the Integrated Child Development Project are absent. But the Commission has received a written statement from the DSWO, Dhubri No. DSWO(D)1136/06/Pt-V/46 dated 06.10.2021.
- 3. From perusal of records it is seen that the appellant Shri Moynal Hoque had submitted an RTI application to the SPIO, "O/o the Social Welfare, Child Development Officer" Dhubri on 10.11.2020 seeking informations related to all Anganwadi Centers under the ICDS offices of Jamadarhat, and Birsing Joruwa, in Dhubri Distt. On not getting any response he submitted a 1st Appeal on 12.01.2021 to the DSWO, Dhubri, and then a 2nd Appeal before this Commission on 02.03.2021. From the statement submitted by the DSWO on 06.10.2021, it is seen that the 1st Appeal of the appellant Shri Moynal Hoque was forwarded to the Programme Officer, Divisional ICDS Cell, Kokrajhar on 21.01.2021, vide letter No. DSWO (D)1136/06/Pt-II/433 dated 20.01.2021, and that the informations have not been provided so far.
- On examination of the RTI petition it is seen that the informations sought relates to all the Anganwadi Centers under jurisdiction of ICDS Project offices of Jamadarhat and Birsing Joruwa from 2015 onwards.
- 5. Since the stipulated period for providing informations to the appellant is over, hence the appellant is entitled to get the informations free of cost. But since the informations sought appear to be voluminous, hence the Programme Officer, Divisional ICDS Cell, Kokrajhar, is directed to organize an inspection of the said voluminous informations so that the appellant Shri Moynal Hoque can see for himself the records and select the particular pages he wants to collect. The said inspection shall be organized according to the convenience of the Programme Officer, Divisional ICDS Project Cell, Kokrajhar, within 15 (fifteen) days from the date of receipt of this order. After the appellant Shri Moynal Hoque inspects and selects the relevant pages, the copies of the selected pages shall be provided to him free of cost. In case he selects more than 100 pages, then first 100 pages shall be provided free of cost and the remaining pages shall be furnished on realization of photocopying charges as applicable. The DSWO, Dhubri shall ensure that this order is carried out by the Programme Officer, Divisional ICDS Cell, Kokrajhar, and an Action Taken Report is sent to the Commission immediately after expiry of the 15 (fifteen) days period. The appellant Shri Moynal Hoque is also directed to inform the Commission accordingly at the end of 15 (fifteen) days.
- 6. With the above order, this 2nd Appeal is hereby disposed of.
