ORDER 07-10-2021

- The appellant Shri Shahjahan Choudhury is absent. But he has authorized Shri Abul Hekam Md Rejwan Choudhury, Advocate, to appear on behalf of him in today's hearing. Accordingly Shri Abul Hekam Md Rejwan Choudhury has submitted a vakalatnama and is permitted to attend this hearing.
- 2. Shri Subhas Ch. Sarkar (PIO) and Assistant Engineer, Hojai Municipal Board is present, and assisted by P.R. Das, Sr. Asstt., Hojai Municipal Board.
- 3. From perusal of records it is seen that the appellant Shri Shahjahan Choudhury submitted one RTI application to the Executive Officer, Hojai Municipal Board, on 26.11.2020, seeking certain informations related to building permission. He later submitted a 1st Appeal in the O/o the Deputy Commissioner, Hojai, on 25.01.2021, stating that he had not received any response to his said RTI application. On 06.03.2021, he preferred a 2nd appeal in this Commission stating that he was aggrieved and dissatisfied on not getting any response from the Public Authority (Hojai Municipal Board) or from the FAA.
- 4. During today's hearing, the PIO, Hojai Municipal Board, Shri Subhas Ch. Sarkar, submitted verbally that his office had not received any RTI application of Shri Shahjahan Choudhury dated 26.11.2020. He also stated that he had neither received any intimation from the FAA in this regard. The PIO even stated that he came to know about the RTI petition of Shri Shahjahan Choudhury, only when he received the notice of hearing from the Commission, in which a copy of the said RTI petition had been enclosed. The PIO however said that the informations sought by Shri Shahjahan Choudhury are ready and can be provided at any time.
- 5. In view of the above, the PIO, Hojai Municipal Board is directed to furnish the informations to the appellant Shri Shahjahan Choudhury within 7 (seven) days from the date of receipt of this order. The PIO as well as the appellant Shri Shahjahan Choudhury are also directed to inform the Commission immediately on furnishing of receipt of the informations.
- 6. With the above order, this 2^{nd} Appeal is hereby disposed of.
