The Commission had in its previous order dated 18.09.2021 put on record that the SPIO, O/o the District & Sessions Judge, Kamrup(M), had provided a written statement in a matter not related to the RTI of the appellant Shri Mridul Kr. Das, but of one Shri Diwakar Choudhury, who had sought some information in relation to Misc(J) case no. 142/2010. Accordingly the Commission had directed the PIO, O/o the District & Sessions Judge, Kamrup(M), to peruse the RTI application of Shri Mridul Kr. Das dated 11.09.2017, information provided to him on 01.12.2017, his 1<sup>st</sup> appeal dated 29.12.2017 and his 2<sup>nd</sup> Appeal of 26.01.2021, and submit a fresh written statement on or before 04.10.2021 i.e. today.
- 4. The SPIO being absent and has also not submitted a written statement as directed on 18.09.2021, he/she is directed to dispose the RTI application of Shri Mridul Kr. Das by providing the necessary information sought within 15 (fifteen) days from the date of receipt of this order, provided there is no court order whatsoever restricting furnishing of the same. The SPIO is also directed to submit an Action Taken Report on this order to the Commission at the earliest.
- 5. With the above order this 2<sup>nd</sup> Appeal is hereby disposed of.
