O R D E R 23-09-2021

1. The appellant Shri Nityananda Kaman is absent. But he has sent a letter dated 23.09.2021 by e-mail, informing about his inability to attend the hearing as his wife has been admitted to hospital.

- 2. The SPIO, O/o the Headmaster, Ujani Subansiri Miri High School, Bilmukh, Lakhimpur, Assam, is absent. But the Commission received an e-mail on 24.09.2021 from the SPIO stating that he had not received the Commission's hearing letter sent by the Commission through registered post. He was intimated about the hearing from the IS office over the telephone only on the date of hearing i.e. on 23.09.2021.
- 3. On perusal of records, it is seen that the appellant Shri Nityananda Kaman had submitted an RTI application in the O/o the Headmaster, Ujani Subansiri Miri High School, Bilmukh, Lakhimpur, on 14.01.2019. On not getting any response, he submitted a 1st Appeal on 04.03.2019 to the FAA, O/o the Inspector of Schools, Lakhimpur.
- 4. On not getting any response he submitted a 2nd Appeal in the Commission on 15.05.2019. Accordingly a hearing was fixed by the Commission on 17.02.2020, which however was not held because of the inability of the SPIO to attend the same in view of the ongoing HSLC Examination. Again hearing was fixed on 03.05.2021 but the hearing could not be held because of the COVID-19 situation.
- 5. In the interest of speedy disposal of the case and to enable the appellant to get the informations sought, the SPIO is hereby directed to furnish the sought for informations within 15 (fifteen) days from the date of receipt of this order. He is also directed to submit an Action taken Report to the Commission at the earliest.
- 6. With the above order, this 2nd Appeal is hereby disposed of.
