ORDER 20-09-2021

- 1. The appellant Shri Manoj Kr. Shahni is absent without any intimation.
- 2. The SPIO, O/o the Sub-Divisional Welfare Officer, Biswanath, is represented by Smti Ananya Lahkar, Asstt. Commissioner, O/o the Deputy Commissioner, Biswanath. She has also submitted a letter of authorization No. BSW/301/Misc./Pt-I/2020-21/92 dated 18.09.2021 issued by the SDO (Sadar) Biswanath & i/c SDWO, Biswanath Chariali. She also submitted a written statement No. BSW/301/Misc./2019-20/90 dated 18.09.2021 of SDO (S) Biswanath and i/c, SDWO, Biswanath Chariali, which contains as annexure the various informations sought by the appellant Shri Manoj. Kr. Sahani in his RTI application dated 05.06.2020.
- 3. The written statement also contains copy of an FIR lodged in the Biswanath Police Station by the i/c Sub-Divisional Welfare Officer, Biswanath Chariali, against Shri Manoj Kr. Sahani, the appellant in the instant matter, alleging forgery committed by Shri Manoj. Kr. Shahni in a matter related to caste certificate. The written statement also has an annexure copy of a letter written by SI of B.Chariali Police Station Faruque Ahmed stating that the appellant Shri Manoj Kr. Shahni against whom an FIR was lodged as mentioned above, has been absconding from the police. There is also copy of a magisterial enquiry report on the allegation of caste certificate forgery against Shri Manoj Kr. Shahni.
- 4. While the SPIO and his authorized representative Smti Ananya Lahkar had submitted to the Commission copies of the informations sought by the appellant, the SPIO is hereby directed to furnish the same, free of cost to the appellant Shri Manoj Kr Shahni within 7 (seven) days from the receipt of this order and obtain an acknowledgement receipt from him and inform the Commission accordingly.
- 5. With the above, order this 2<sup>nd</sup> Appeal is hereby disposed of.
