<u>O R D E R</u> 09-09-2021

- 1. The appellant Shri Harinarayan Pathak is present.
- Smti Alivia Deka, SPIO, and Assistant Industries Officer, O/o the Engineer, i/c Central Workshop & Manager Industrial Estate, Bamunimaidam, Guwahati is present. She has also submitted a written statement No. CWG(E)747/2009/Part-I/625 dated 09.09.2021.
- 3. Perused the written statement mentioned above. The SPIO in her written statement said that "all available office records were searched" but no information as sought by the appellant could be traced in the office. The SPIO has also said that the informations sought by the appellant was very old in nature and therefore could not be traced; and that the petitioner was informed about this twice by the SPIO. The SPIO has also stated that while the O/o the Engineer, i/c Central Workshop & Manager Industrial Estate, has been declared to be office of the Assam Industrial Infrastructure Development Corporation (AIIDC), hence the files and documents of the O/o the Engineer, i/c, Central Workshop & Manager Industrial Estate, "is not properly maintained due to insufficient manpower."
- 4. The appellant during today's hearing however claimed that he was not satisfied with the SPIO's claims that the informations could not be traced out.
- 5. In view of the above, the SPIO is directed to bring this issue of "insufficient manpower" to the notice of the appropriate authority in the AIIDC, make an effort to trace the relevant documents and provide the appellant with the informations sought. The SPIO is also directed to provide whatever information available with her to the appellant within 30 (thirty) days from the date of receipt of this order. The SPIO is also directed keep the appropriate in the AIIDC informed, and submit an Action Taken Report to the Commission accordingly.
- 6. A copy of this order be also marked to the Managing Director, Assam Industrial Infrastructure Development Corporation Ltd. Bamunimaidam, Guwahati, for information and necessary action.
- 7. In view of the above, this 2nd Appeal is hereby disposed of.
