- <u>O R D E R</u> 09-08-2021
- 1. The petitioner Shri Arun Sarawgi is present.
- 2. Shri Hitesh Sarma Medhi, SPIO, Guwahati Metropolitan Development Authority (GMDA) is present.
- 3. The SPIO has also submitted a written statement No. GMDA/RTI/2020/91/111 dated 05.08.2021 providing an Action Taken Report on the RTI petition of Shri Arun Sarawgi.
- 4. On perusal of Action Taken Report it is seen that it has as annexure order (GMDA/RTI/2020/91/101 dated 01.07.2021) issued by the First Appellate Authority of GMDA and copies of letters by 3 (three) third parties in response to a letter of request for consent written by SPIO. It also contains a copy of letter No. GMDA/RTI/2020/91/108 dated 06.07.202, written by the SPIO to the appellant informing him that the concerned third parties have not given consent for sharing information that the appellant has requested for.
- 5. During today's hearing the appellant Shri Arun Sarawgi has verbally contended that he has however the right to the information as he is a stake holder of the said apartment building regarding which he has sought certain information.
- 6. In view of the appellant's contentions in response to which the SPIO has prayed for appropriate order, the Commission directs the SPIO, GMDA, to provide the informations sought for by the appellant as are furnishable under provisions of the RTI Act, 2005 within 15 (fifteen) days from the receipt of this order.
- 7. With the above order this 2^{nd} Appeal is hereby disposed of.
