- 1. The appellant Shri Deba Datta Keot is present.
- The SPIO, Elementary Education Department, Govt. of Assam, Dispur, Guwahati, is absent. But the SPIO has sent a written statement No. AEE(RTI)6/2020/105 dated 21.03.2021, in reference to this hearing.
- 3. From perusal on records it is seen that the appellant Shri Deba Datta Keot had submitted one RTI application to the SPIO, O/o the Commissioner & Secretary, Elementary Education Department, Govt. of Assam, Dispur, Guwahati on 07.06.2020, seeking two informations i) what steps had been taken on a petition Shri Deba Datta Keot had submitted to the Commissioner & Secretary, Department of Elementary Education, Govt. of Assam, Dispur, Guwahati, on 28.05.2020, and ii) copy of orders issued by the Commissioner and Secretary, Elementary Education Department, on two particular points mentioned by the appellant Shri Deba Datta Keot in which petition dated 28.05.2020. From perusal of the written statement submitted by the SPIO, Elementary Education Department, Govt. of Assam, it is seen that there is no specific response to the two queries that Shri Deba Datta Keot had made in his RTI application dated 07.06.2020. The appellant Shri Deba Datta Keot's 1st RTI query was simple What steps were taken on his petition to the Commissioner and Secretary, Elementary Education Department Govt. of Assam on 28.05.2020.
- 4. Since the written statement of the SPIO, Elementary Education Department does not address the two queries in the RTI petition of Shri Deba Datta Keot, hence the SPIO, Elementary Education Department is directed to specifically reply to his two RTI queries, more particularly the 1st query, within 21 (twenty-one) days from the receipt of this order and inform the Commission accordingly.
- 5. With the above order, this 2nd Appeal is hereby disposed of.
