ORDER 18/02/2022

- 1. The petitioner Sri Utpal Das has filed his RTI petition before the PIO, Revenue & Disaster Management Department, Govt. of Assam, Dispur, Guwahati on 26.7.2021 seeking following information:
  - (a) Please furnish the information whether the Assam Shishu Sahitya Niyakh of Chandmari, Guwahati has received any allotment order over the land where they constructed building at Chandmari, Near Assam Engineering College, Guwahati 3 or not.
- 2. On non receipt of any information, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, Revenue & Disaster Management Department, Govt. of Assam, Dispur, Guwahati on 27.8.2021. Then he filed 2<sup>nd</sup> appeal before the Commission on 8.12.2021 and accordingly the matter was taken up for hearing.
- 3. The petitioner Sri Utpal Das is present.
- 4. The Public Authority is represented by Sri Ananda Kumar Das, ACS, SPIO & Joint Secy., Revenue & Disaster Management Dept. Dispur and he is accompanied by Smti Sukanya Bora, SDO(S), ASPIO, O/o the Deputy Commissioner, Kamrup(M).
- 5. The SPIO, O/o the Deputy Commissioner, Kamrup (M), Guwahati submitted a report dated 17.2.2022 stating that the RTI petition was transferred to the Deputy Commissioner, Kamrup (M) vide letter no. ECF No.180089/2021/4 dated 16.11.2021 and then RTI Branch, Kamrup (M) transferred the application to the Circle Officer, Guwahati Revenue Circle vide letter no. RTI 33/2022/99 dated 10.2.2022 with a direction to furnish the information directly to the applicant within 30 days and on perusal it is seen that the information has already been provided to the petitioner vide letter dated 17.2.2022.
- 6. Since the information has already been given, <u>the Commission disposes the</u> <u>cases with direction for collection of the copy of the letter from the Circle Officer,</u> <u>Guwahati Revenue Circle, as the appellant has said that he has not received the information.</u>
- 7. In view of the above, the case is disposed off.
