O R D E R 18/02/2022

- 1. The petitioner Sri Joydeb Das has filed his RTI petition before the PIO, Assam Shishu Sahitya Nyas, Krishna Nagar, Chandmari, Guwahati on 8.11.2021 seeking following information:
 - · Required Information: Construction of Building.
- (i) Whether any land allotted by the Government in the name of Shishu Sahitya Nyas for construction of department building, if yes, please furnish a copy of land allotment order.
- (ii) If land allotted, please furnish a copy of proposal of Shishu Sahitya Nyas sent to the Government and copy of Government sanction order to be given.
- (iii) Please furnish a copy of the proposal sent to the Government to sanction of land for construction of the building along with names and designations of the officers who sent to the Government to sanction of fund for said construction.
- (iv) Please furnish a copy of Government sanction/sanctions for construction of the building.
- (v) Please furnish copy of the plan of the building, ceiling released and completion certificate.
- (vi) If any tender was floated for said construction, if yes, please furnish a copy of NIT, Bid Document and copy of tender evaluation committee for selection of contractor with copy of the comparative statement and bill.
- 2. On non receipt of any information, the petitioner filed a complaint petition u/s 18(1) of the RTI Act,2005 before the Commission on 22.12.2021 and accordingly the hearing was taken up today.
- 3. The petitioner Sri Joydeb Das is present.
- 4. The Public Authority to be represented by SPIO, O/o the Assam Shishu Sahitya Nyas, Krishna Nagar, Chandmari is absent without any intimation which is contrary to the provision of RTI Act, 2005.
- 5. Since the SPIO is absent, the Commission has decided to hear the matter again.
- 6. Fix another date of hearing.

Issue notice to the SPIO, O/o the Assam Shishu Sahitya Nyas, Krishna Nagar, Chandmari, Guwahati to appear physically on the next date of hearing.
