O R D E R 23/02/2022

- 1. The petitioner Sri Joydeb Das has filed one RTI petition before the Public Information Officer, O/o the District Home Guard Commandant, Sonitpur, Assam on 25.11.2021 seeking following information:
 - (i) Whether any temple has constructed in the premises of District Home Guard Commandant Office, if yes, please furnish following details:-
 - (a) Has any Managing Committee formed in connection with smoothly operating of Temple, if yes, please furnish the name and designation of the member and date on which committee has formed.
 - (b) Has any donation being collected for operating of the Temple, if yes, please furnish an amount of donation collected from whom since inception to till on day along with copies of bank statement till date.
 - (c) Please furnish in details of the fund involved regarding development of Temple and source of fund from since inception to till on day.
- 2. On non receipt of any information the petitioner has filed one complaint petition u/s 18(1) before the Commission on 17.1.2022 and accordingly, the matter was taken up for hearing.
- 3. The District Commandant, Home Guard, Sonitpur has submitted a written statement which is received at the Commission on 21.2.2022 is taken into records.
- 4. The petitioner Sri Joydeb Das is present and prayed to convert his complaint petition into 2nd appeal petition.
- 5. The Public Authority is represented by SPIO, O/o the District Home Guard Commandant, Sonitpur, Assam is absent.
- 6. The petitioner stated that he is not satisfied with the reply as there is temple out there and for construction money is spent, source of fund and collection if any from the Home Guards etc. is not given. Reply is very vague and he is not satisfied.
- 7. Since the SPIO is absent no reply to the petitioner can be furnished. The Commission has decided to hear the matter again.
- 8. Fix 21.3.2022 at 11:15 AM as the next date of hearing. Intimate SPIO to attend without fail.
