 - Whether the Departmental promotion committee has been recommended to Shri Ashok Sharma as Executive Engineer, Engineering wing, H.Q. Khanapara-22 promoted to as Superintendent Engineer, if yes, please furnish following details:
 - a. Please furnish a copy of the minutes of the meeting in connection with promotion, along with all the copy of the file noting.
 - b. Please furnish a copy of under which procedure following regarding prior promotion, wherein a case has already been registered in CBI bearing case No. 03/2015 as well as in pursuance of existing office memorandum of Ministry of Personnel, Public Grievance and Pension (Department of Pension and Training) dated 02.11.2012.
 - c. If any departmental proceeding drawn, if yes, please furnish a copy of the same.
 - d. If no any departmental proceeding drawn before retirement of said officer, please furnish reason/s thereof.
 - 2. However the Commission thinks that question No. 1(d) is not to be considered under RTI Act as information.
 - 3. On 30.12.2021 the Department has given partial information without enclosures. Hence on 17.01.2022, he filed a complaint petition before the Commission. And accordingly the hearing was taken up today.
 - 4. The petitioner has written before the Commission to convert his complaint petition into 2nd Appeal petition.
 - 5. The petitioner Shri Joydeb Das is present.
 - 6. The Public authority is represented by Smti Juri Dutta, Under Secretary, Agriculture Deptt. Assam Secretariat, and she has submitted a written statement dated 22.02.2022 giving all connected papers.
 - 7. The Commission directs the Registry to give a copy to the petitioner.
 - 8. The case is disposed off.
