# O R D E R 21/02/2022

- 1. The petitioner Sri Joydeb Das has filed his RTI petition before the Public Information Officer, Personnel (A) Department, Secretariat, Dispur on 03.12.2021 seeking following information:
  - (a) Please furnish copy of qualification certificate, caste certificate and other documents submitted at the time of appointment by Shri Bipul Das, ACS presently working as ADC in Kamrup (M) along with a copy of appointment letter.
  - (b) Please furnish whether documents has ever verified which was submitted at the time of appointment and prior issued of appointment letter.
- On non receipt of any information, the petitioner filed a complaint petition u/s 18(1) of the RTI Act,2005 before the Commission on 17.1.2022.

Accordingly, the matter was taken up for hearing.

However, the petitioner has written before the Commission to convert his complaint petition into 2<sup>nd</sup> appeal u/s 19(3) of the RTI Act,2005.

- 3. The petitioner Sri Joydeb Das is present.
- 4. The Public Authority to be represented by SPIO, Personnel (A) Department, Dispur is absent. However, the Deputy Secretary to the Govt. of Assam, Personnel (A) Department has sent an email dated 17.2.2022 stating that the SPIO is on earned leave from 21.1.2022 to 9.3.2022 on medical ground because of which the SPIO is unable to attend the hearing.
- 5. Since the SPIO is absent, the Commission has decided to hear the matter again.
- 6. Fix another date of hearing.
