O R D E R

1. The petitioner Sri Joydeb Das has filed his RTI petition before the Public Information Officer, Vigilance & Anti-Corruption, Srimantapur, Guwahati on 17.11.2021 seeking following information:
(a) Whether any case has been registered in connection with my complaint petition which was submitted on 10.11.2020, if yes, please furnish following details:
(i) Please furnish case number with section of law and details of investigation was done till on day.
(ii) Please furnish date wise report submitted to the Hon'ble Court, if report submitted.
(iii) If, no any action was taken till on day, please furnish reason thereof.
2. The petitioner then filed a complaint petition u/s18(1) of the RTI Act,2005 before the Commission on 17.1.2022. Accordingly, the matter was taken up hearing.
However, the petitioner has written before the Commission to convert his complaint petition into 2nd appeal u/s 19(3) of the RTI Act,2005.
3. The petitioner Sri Joydeb Das is present.
4. The Public Authority to be represented by SPIO, Directorate of Vigilance & Anti-Corruption, Guwahati is absent. However, the SPIO has submitted a written statement dated 19/2/2022 stating that the FIR of the petitioner is forwarded to the Principal Secretary to the Govt. of Assam, Welfare of Plain Tribes & Backward Classes Department, Dispur, Guwahati vide Directorate letter no. DGVA/C/2021/110 dated 22.2.2021.
5. The petitioner claims that FIR at the Department Vigilance & Anti-Corruption should have registered at the Police Station of the Directorate rather than forwarding it to the Principal Secretary for taking necessary action.
He further stated that he has not received a copy of this letter.
6. The Registry of this Commission is directed to furnish the copy of the letter to the petitioner.
7. In view of the above, the case is disposed off.
