## O R D E R 21/02/2022

- 1. The petitioner Sri Joydeb Das has filed his RTI petition before the Public Information Officer, Vigilance & Anti-Corruption, Srimantapur, Guwahati on 17.11.2021 seeking following information:
  - (a) Whether any case has been registered in connection with my complaint petition which was submitted on 10.11.2020, if yes, please furnish following details:
  - (i) Please furnish case number with section of law and details of investigation was done till on day.
  - (ii) Please furnish date wise report submitted to the Hon'ble Court, if report submitted.
  - (iii) If, no any action was taken till on day, please furnish reason thereof.
- The petitioner then filed a complaint petition u/s18(1) of the RTI Act,2005 before the Commission on 17.1.2022. Accordingly, the matter was taken up hearing. However, the petitioner has written before the Commission to convert
- his complaint petition into 2<sup>nd</sup> appeal u/s 19(3) of the RTI Act,2005.
- 3. The petitioner Sri Joydeb Das is present.
- 4. The Public Authority to be represented by SPIO, Directorate of Vigilance & Anti-Corruption, Guwahati is absent. However, the SPIO has submitted a written statement dated 19/2/2022 stating that the FIR of the petitioner is forwarded to the Principal Secretary to the Govt. of Assam, Welfare of Plain Tribes & Backward Classes Department, Dispur, Guwahati vide Directorate letter no. DGVA/C/2021/110 dated 22.2.2021.
- 5. The petitioner claims that FIR at the Department Vigilance & Anti-Corruption should have registered at the Police Station of the Directorate rather than forwarding it to the Principal Secretary for taking necessary action.
  - He further stated that he has not received a copy of this letter.
- 6. <u>The Registry of this Commission is directed to furnish the copy of the letter to the petitioner.</u>
- 7. In view of the above, the case is disposed off.
