i) Please furnish authentication of above "Tie Up Agreement" two copies) of "Dhaincha" var. V Plant and V-Dhaincha DH 2 respectively which are countersigned by District Agricultural Officer, DAO, Barpeta dated 30.10.2022, along with copy of verified statement of DAO regarding existence of above Pathar Parichalana Samitee's and area of land cultivated by each grower with name and date of sowing.
2. On non receipt of any information, the petitioner filed a complaint petition u/s 18(1) of the RTI Act,2005 before the Commission on 1.2.2022.
Accordingly, the matter was taken up for hearing.
3. The petitioner is present.
4. The Public Authority to be represented by SPIO, O/o the District Agricultural Office, Barpeta is absent.
5. However, the petitioner has sent an email dated 28.3.2022 wherein he has mentioned that he has received the sought for information from District Agriculture Office, Barpeta.
