## O R D E R 24/03/2022

- 1. In continuation of earlier order dated 14.3.2022, the matter was taken up for hearing today.
- 2. The petitioner Sri Joydeb Das is present.
- 3. The Public Authority is represented by Dr. Nitul Gogoi, IPS, Inspector General of Police (Admin.), Assam Guwahati.
- 4. The petitioner said that vide letter no. G(RTI)/VI/128/2021/43 dated 16.3.2022, he has received part information, however details of some other information relating to his RTI petition is not clear.
- 5. Regarding information provided by the Inspector General of Police (A), Assam, Ulubari, Guwahati on behalf of SPIO vide letter no. G(RTI)/VI/128/2021/20 dated Guwahati 1<sup>st</sup> February 2022 which *quote* Officer from Assam-Meghalaya Cadre can retain Govt. accommodation when posted to other North-East States or hard posting. He is entitled to keep his family in the Assam Govt. Quarter, when posted in hard area posting. *Unquote*. And letter No.G(RTI)/VI/128/2021/43 dated Guwahati 16.3.2022 which *quotes* Headquarters office memorandum dated 26.11.2019 the Officer occupied the Govt. quarter.(copy of memorandum enclosed) *Unquote* 
  - The petitioner says that the above reply is devoid of any Government notification and copy of the same is to be provided whether the officer when posted out of Assam to Meghalaya can retain quarter in Guwahati(Assam) or not?
- 6. The Commission directs the SPIO to provide Government notification if any in this regard and provide specific copy of DGP order on providing family accommodation in Assam Government Quarter when the officer is posted out from Assam to other North Eastern States.
- 7. The petitioner stated that details of the Class IV personnel is not given. Though, the letters says that they are already withdrawn.
- 8. At this point, the IGP (on behalf of SPIO) said that why the petitioner could ask for these information, to this the petitioner replied that he doubts the corruption angle in detailment and misuse of Government resources.
- 9. The Commission after careful examining the contention of the IGP on behalf of SPIO and the petitioner, also feels that in public interest and for transparency purpose scarce resources of Police Department cannot be diverted and allegedly unjustifiably deployed. Hence, this information ought to be given.
- 10. In light of it, the Commission directs the SPIO to furnish details of non security personnel from 4<sup>th</sup> APBN/ and any other place deployed with their date of deployment and date of release.
- 11. In addition to information available at the headquarters, the SPIO may collect information from the Office of T&AP, Ulubari, Guwahati and furnish the same within 7 days.

12. The case is disposed off.
