O R D E R 02/03/2022

- 1. In continuation of earlier order dated 25.2.2022 the SPIO, Sri Kumud Chandra Das, Under Secretary to the Govt. of Assam, Higher Education Department has submitted a report stating that letter of this Commission was received by the Computer Operator, but he was unable to furnish any record regarding dispatch to the SPIO for which SPIO could not take any action.
- 2. It is quite unfortunate that the Under Secretary & SPIO instead of bringing this to the notice of the Principal Secretary to fix responsibility, has casually mentioned that the letter is not received by his office. It is total callousness and avoiding of the responsibility.

Since he is functioning of behalf of the Principal Secretary, the matter should have been brought to the notice of the Principal Secretary and necessary action could have been taken in tracing the letter.

 Coming to the reply of the RTI petition, the SPIO has sent a casual letter to the petitioner stating that The Higher Education Department, Assam issued a letter to the Director of Higher Education (DHE), Kahilipara, Guwahati requesting to submit No Objection Certificate regarding opening of GPF vide letter No. AHE.229/2020/9 dated 7.7.2021.

But after that, no further communication from the DHE, or from the Department, has been made so far, as per records available.

4. Since the SPIO has personally got the enclosures in the last date of hearing, he is directed by the Commission to come prepared in the next date of hearing with meaningful reply to the petitioner.
