O R D E R 02/03/2022

- 1. The petitioner Smti Jayashree Paul has submitted one RTI petition before the Superintendent of Police, Hailakandi on 5.7.2021 seeking following information:
 - (a) What action is taken on my F.I.R. No. 798/2018 dated 2.10.2018 lodged in Hailakandi Police Station.
 - (b) Why no action is taken to arrest the culprits even after two years.
 - (c) Why no action is taken to retrieve money from the cheater even after two years.
- 2. On non receipt of any information, the petitioner filed 1st appeal before the 1st Appellate Authority/ Deputy Inspector General of Police (SR), Park Road, Tarapur, Silchar on 23.8.2021 and then she filed 2nd appeal before the Commission on 1.12.2021.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner Smti Jayashree Paul is absent without any intimation.
- 4. The Public Authority to be represented by SPIO, O/o the Superintendent of Police, Hailakandi is also absent. However, the SPIO has submitted a written statement dated 1.2.2022 stating that reply to the RTI petition has already been sent to the appellant on 14.9.2021 wherein point wise reply to the petitioner is given as follows:

<u>Point No.1 of the RTI petition</u>: During investigation, I/O visited the P.O. and recorded the statement of complainant u/s 161 CrPC, I/O also served notice u/s 91 CrPC to all the concerned Bank Managers to find out the transaction as well as Bank details of the suspected accused. Now the case is under investigation.

<u>Point No. 2 of the RTI petition</u>: Investigation is on to nab the actual culprit behind the crime.

<u>Point No.3 of the RTI petition:</u> Since the type of crime was white colour and the accused has used various tools like false mobile no., fake bank accounts etc. Therefore, the search is on to find the suspected accused.

- 5. The SPIO over phone also intimated that the RTI petition in present form is not sustainable, as the petitioner instead of asking for information is putting questions like what and why.
- 6. On perusal of the reply submitted by the SPIO, the Commission accepts it and disposes the case.
- 7. However, since the case is quite old, the Commssion desires that investigation to be undertaken in conformity with provision u/s 173 CrPC.
