## O R D E R

- 1. The petitioner Sri Nityananda Kalita has filed one RTI petition before the SPIO, O/o the Deputy Commissioner, Kamrup (M), Guwahati on 1.9.2021 seeking some information relating to 2014-15 and case no.2063 at the Circle Office, copy of order dated 3.10.2014.
- 2. The DC Office Kamrup forwarded the RTI petition to ADC, Land Record Branch on 3.9.2021. Then on 21.9.2021, the Addl. Deputy Commissioner, Kamrup (M) forwarded the same to the Circle Officer, Guwahati Revenue Circle.
- 3. The petitioner then filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, O/o the Deputy Commissioner, Kamrup on 12.1.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 24.2.2022.

Accordingly, the matter was taken up for hearing.

- 4. The petitioner is present.
- 5. In the meantime, the Circle Officer of Guwahati Revenue Circle submitted a written statement dated 24.3.2022 wherein it is stated that he was unable to provide the required information within stipulated time due to inability to trace out the case record of mutation case 2063/2014-15. However, the photocopies of the mutation is enclosed is enclosed with the written statement.
- 6. The petitioner has filed two such petitions today where he is unable to justify any public interest in those two cases, and in this particular case, he says that he has filed this RTI petition on behalf of one of his uncle Tilak Choudhury. The petitioner is directed to intimate Sri Tilak Choudhury to collect a copy of this from the Registry of the Commission.
- 7. The case is disposed off.
