O R D E R

- 1. The petitioner Sri Ajit Sharma has filed one RTI petition before the Public Information Officer, O/o the Commissioner, Guwahati Municipal Corporation on 8.11.2021 seeking some information.
- 2. On 26.11.2021 the petitioner was furnished with the information by the PIO of Guwahati Municipal Corporation, Guwahati.
- 3. On not being satisfied with the information received, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the Commissioner, Guwahati Municipal Corporation, Guwahati on 8.12.2021 and then he filed 2nd appeal before the Commission on 11.2.2022.

Accordingly, the matter was taken up for hearing.

- 4. The petitioner is absent but because of his old age ailments he deputed one Bipin Thakuria to represent him.
- 5. The Public Authority is represented by Nabajyoti Bardoloi, Executive Engineer & Deemed PIO, GMC and he is accompanied by Kishoor Kr. Das. Assistant Executive Engineer, GMC.
- 6. The PIO of Guwahati Municipal Corporation has submitted a written statement dated 24.3.2022 which is taken into records.
- 7. The petitioner says that the Act relates to Annual Rate Value (ARV) and relevant section of the Act mentions 7.5% ARV which is to be given. The copy of the Act to be given.
- 8. The Deemed PIO mentions that the petitioner mentions about it in his 1st appeal petition, since the Act is a public property and in public domain, the Commission decides to give a photocopy of the same to the petitioner.
- 9. In view of the above, the case is disposed off.
