**O R D E R**  
**10/03/2022**

1. The petitioner Sri Joydeb Das has filed one RTI petition before the Public Information Officer, Assam Fishery Development Corporation, Mahapurush Madhavdev Path, Chachal, Guwahati on 11.11.2021 seeking following information:
  - (i) Whether any advertisement published for recruitment of various post in AFDC during the period 2017-18 to till date, if yes, please furnish following details:
    - (a) Please furnish all the copy of advertisement with minutes of the Governing Body and copy of appointment letter of selection candidate.
    - (b) Please furnish in details of the name of the applied candidate and selected candidate with date of interview held for recruitment.
    - (c) Please furnish in details name of the member of selection/rejection committee, along with a copy of minutes of the selection/rejection committee.
2. On non receipt of any information, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, Assam Fisheries Development Corporation Ltd. Chachal, Guwahati on 15.12.2021 and then he filed 2<sup>nd</sup> appeal before the Commission on 14.2.2022.

Accordingly the matter was taken up for hearing.
3. On 8.3.2022 the petitioner and the SPIO Sri Deisaulungbe Pame were present. But the SPIO was not prepared with full information, so the Commission has decided to fix another date of hearing verbally for 10.3.2022.

Accordingly the matter was taken up for hearing.
4. On the hearing, the SPIO said that since there was no advertisement for recruitment of various post in AFDC during the period 2017-18 till date, the reply to the sub questions of question no (i) does not arise.
5. The petitioner was insisting that as per his knowledge some people are appointed, so appointment letters of those candidates should have been given. But the SPIO said that question no.(i) talks about advertisement and as there is no advertisement, copy of appointed people cannot be given.
6. In light of the above, the Commission advises the petitioner to seek specific information, if he wants to do so.
7. The case is disposed off.
